WALK – IN- INTERVIEW FOR THE POST OF JUNIOR RESIDENT (Dental) ON adhoc Basis TO BE HELD ON 13/08/2023 subject to result for written Examination held on same day.

Deep Chand Bandhu Hospital invites applications for a written exam & Walk-in-interview for filling up **One Vacant Post of Junior Residents (Dental) under SC category on adhoc basis**. Only candidates who fulfill the eligibility criteria as per Residency Scheme may appear before the interview panel on **13/08/2023** 9:30 AM to 10:30:00 AM with their original documents.

Qualification:-BDS Degree from a recognized University/Institution and must possess valid Registration Certificate from Delhi Dental Council/ Dental Council of India.

Internship:-Candidates who have completed internship earlier than 2 year at the time of interview shall not be eligible.

Pay Scale:- Pay of Rs. 56100/- as per 7th CPC level 10 plus allowances as admissible under the rules.

Age:40 years for General, 5 years relaxable for SC/ST and 03 years for OBC candidates (belonging to Delhi only) OBC candidates are required to submit their caste certificate (Issued before the date of application) along with the Non Creamy Layer Certificate of Current Financial Year.

Tenure: Initially appointment for a Period of 89 days and the same can be extended for a further period of upto One year subject to satisfactory work and conduct report and performance.

The Maximum tenure of Junior Residents(MBBS) is for a period of OneYear only including any service rendered as Junior Resident earlier on ad-hoc/regular basis in any recognized institution. The tenure can be extended further upto a maximum period of 01 year subject to satisfactory performance, work and conduct report from concerned HOD.

Relaxation of provision as per circular No. F.121/26/2010/H&FW/1996-2045 dated 10.06.2011 of Deptt. of H&FW, GNCT of Delhi. If the fresh candidate is not available then following relaxation may be applicable:-

1. Upper age limit for eligibility for JR will be 40 years.
2. In case of non availability of fresh candidates, candidates who have completed one year Residency as J.R. may also be allowed to appear in the interview.
3. Separate merit lists for fresh candidates and for others (i.e. those who have already completed one year Junior Residency) would be prepared.

4. Firstly, the list containing the names of fresh candidates would be exhausted for appointment and the second list would be used only after that.
5. Reservation of Person with Disability will be as per Government Rules.

Other conditions/requirements:-

iii. **Hostel accommodation is compulsory.**

- iv. The candidates who are already in govt. service should submit an NOC from his/her Employer.
 - The services of Junior Residents shall be governed by residency schemes of Govt. of India/Civil Services (Temporary Rules).

1. Candidates are required to bring all original certificates and testimonials along with two passport size photographs on the date of interview.

2. Appointment shall be subject to medical fitness & verification of certificates.

3. No TA/DA will be paid for appearing in the interview.

4. Reservation of Person with Disability will be as per Govt. Rules.

Submission of application:

Interested and eligible candidates may apply in the prescribed format with self attested copies of all testimonials and certificate i.e list of documents Date of birth certificate (Metric Certificate), BDS degree Certificate, Internship Certificate, Degree/Diploma, Caste Certificate DMC registration Certificate and Proof of Permanent Address . Application after 10:30 AM will not entertained.(without DMC not accepted)

Note:-Final year Marksheet and attempt certificate must be provided by candidates applying for the post of Junior Resident Dental. Only candidates, who have secured 60% U/R category and 5% waiver for SC/ST and OBC category, above in final professional examination of BDS, will be considered for the interview.
